OAK HARBOR SEWER SYSTEM IMPROVEMENTS

Funding Source: GOMESA

Funding Amount: \$2,811,548

Phase 1: Acquisition of privately-owned water and sewer systems

Legal: Transaction for ownership from Utility Services to HCUA completed

Phase 2: Replacement of lift stations and force mains design completed

Legal: One lift station site given to HCUA from the Secretary of State. Other site owners are willing to sell. A date needs to be scheduled for the completion of sale.

Update: Completed the interconnection between the Pearlington Water Distribution System and the Oak Harbor Water Distribution System. Well and Tank shut down and taken offline in Oak Harbor. Tank removed from Well site. Design for Sewer System Improvements has been completed. Project has been advertised and will take bids on July 15, 2025. Took bids and are still evaluating the information. Recommendation and Bid Tab to distribute to the Board in September. PWSD is working on water leaks.

STENNIS SPACE CENTER WASTEWATER CONVEYANCE

Possible Funding Sources: American Rescue Plan and/or GCRF

Funding Amount Requested: \$10,600,000

Status: Information packet submitted to local legislators for review/support and possible funding. Also, recently submitted to MDMR for the GOMESA funding.

NASA is proceeding with upgrading their sewer collection system and plans to construct the necessary pump stations and force mains within their area to convey all their wastewater to their property limits. The HANCUA project will connect to the NASA project at this point for conveyance of wastewater to the Northern Regional WWTF.

Update: All pipe on Texas Flat Rd. has been installed. Received easement for the Mainline Road pipe. Both Lift Station sites have the Wet Well's in place. Continuing to work on them. Made design modification to the connection of the influent pump station.

Funding Amount Requested: \$1,500,000 – ARPA

Status: Received Funding from ARPA to go along with BOS.

Update: Clearing and grubbing is completed at all sites. Fence complete. Ground Penetrating Radar study completed. Bore completed. All anchor installations are completed. All racking and panels are completed. Inter-Connection completed at South Plant and West Plant. The connections are made at all plants. Still waiting on the panel boards for the North and South Plant. Need a contactor installed at the Western plant. Estimated online dates for all plants will be September.
